Marshall Ott is a first cousin of ours. We have known Marshall all our lives. Marshall is basically a very bright individual with alot of enthusiasm for life and all its challenges.

Dear Dr. Ott:

Enclosed are copies of two letters that one of the investors had written to enlighten other investors of the situation with regard to Marshall. There is also a copy of the notarized letter he sent as a character witness inasmuch as he was unable to come in person to testify at the trial.

Hampered by all his assets having been confiscated, Marshall was unable to hire an attorney, so Mr. Brown was his court-appointed attorney. We have since learned that he was not working in the best interest of Marshall.

An appeal needs to be filed within 10 days, and a change of venue is necessary in order for him to get a fair trial, or he is likely to be incarcerated for the rest of his days—and he has done no wrong! The D.P.S. officer and the prosecuting attorney and their hired witnesses have lied trying so desperately to get the property away from Marshall and Mary Ann.

If you can find it in your heart to give Marshall your support, it would mean so much to him at this crucial time. You may be unaware that during his incarceration he was severely beaten for no reason at the instigation of the guard on duty (obviously on order from someone "higher up") and he was left bleeding, with broken ribs, kidney injuries, lacerations and bruises both facial and on his body, and not given medical attention until the next round of guards came on duty several hours later and found him. He had been threatened with being killed at the time of the beating unless he promised not to tell

On the occasion of one of his previous hearings, the Judge was overheard to practically shout, "We have to GET something on this guy." The Judge was talking to the two lawyers in his chambers at the time.

We have hired a legal investigator for a few hours to interrogate the the jurors from Marshall's trial to discover why it took 2 1/2 days to reach a verdict of guilty on all counts. We, and the investigator think some bribery was involved and we need evidence to present to a hired attorney. We cannot afford to pay for him—alone—will you help? We aren't trying to save our investments, we are trying to save your son. HE WAS FRAMED!!!

(see Jer. 17:5-9).

Well, Mom, this is about enuf for now and hope I have not bored you or "rambled" on like several opposed to me and a couple lying prosecutors have tried to say, but rather, that you will see, as you will see, I am, and have always told you the truth in the past, as I am now, totally innocent.

Because they don't know any better, and because people get carried away sometimes, some endeavor to guide people's lives through spiritual gifts and prophecy. Then others who claim to be prophets or claim to minister along this particular line lead people astray.

It is interesting to note that in Acts 21:10 and 11, Luke said, "And as we tarried there many days, there came down from Judaea a certain prophet, named Agabus. And when he was come unto us, he took Paul's girdle, and bound his own hands and feet, and said, Thus saith the Holy Ghost, So shall the Jews at Jerusalem bind the man that owneth this girdle, and shall deliver him into the hands of the Gentiles."

Did you notice that Agabus did not give Paul any guidance? He didn't tell Paul to go or not to go, he simply told him what the Holy Spirit said was going to come to pass. There was no guidance there.

#### Blessing or Abuse?

Sometimes there is just a shade of difference between the real and the false; a fine line between that which is helpful and good, and that which is a hindrance and hurtful; between that which is a blessing and that which is abuse and misuse. I've seen what has happened to those who have listened to what someone else said by a so-called prophecy.

Some have entered into marriage because of a "prophecy" and their lives have been ruined. Ministers have changed churches and have entered into other ministries because of so-called prophecies, and these ministers were never able to regain and recover their loss. Businessmen have been terribly hurt. Listening to someone who claimed to have a revelation from God, they invested their money and went bankrupt.

I can't find any place in the New Testament where through a prophet's ministry anyone was told how to invest his money. You understand, of course, there could be an exception occasionally to all rules, but when people make a habit of things and develop some kind of a "system" for receiving guidance in life, I'm wary of it, because it's not scriptural.

Jesus told me — and the Bible agrees with it — that the number one way He leads is by an inward witness.

There is a helpful little statement in Acts 13, a clue that would help us in receiving guidance from God, or hearing the voice of the Lord.

#### ACTS 13:12

1 Now there were in the church that was at Antioch certain prophets and teachers; as Barnabas, and Simeon that was called Niger, and Lucius of Cyrene, and Mennas, which had been brought up with Herod the tetrarch, and Saul.

2 As they ministered to the Lord, and fasted, the Holy Ghost said...

I think we need to have some services where we don't minister to the people, but we minister to the Lord. I'm very busy with calls and invitations and so on, but I take time to get alone with the Lord and minister to Him and wait on Him. In those times I sometimes receive enough guidance for my own personal life and ministry to last a year or longer. That doesn't mean I stop ministering to the Lord and seeking Him, however.

That's a whole lot better than going along not knowing where you are going and just praying and "kicking, clawing, and sputtering," trying to get help. Sometimes you have to keep going and you don't have time. But it is sort of like getting on a freeway — you had better know where you are going before you get on it!

Prior to this vision, as I had been waiting on the Lord and ministering to Him, something came to me concerning a certain man. I dismissed it at first, and thought perhaps the thought of it had just come to my mind. But as I continued to wait on God, it kept coming to me. Then at different times over a period of days, it kept coming to me.

After several days, I finally said to the Lord, "Now Lord, do you want me to go there to hold a meeting?" The more I thought about it, the better I felt about it on the inside of me. I didn't have any check at all; I seemed to have a green light.

#### The Green Light

So when the Lord appeared to me in this vision, He reminded me of that. He said, "That green light, so to speak, which you had in your spirit was the witness of the Holy Spirit to go there. Now you see Me and hear My voice as I speak to you. I'm telling you I want you to go there because there are a number of professional people in his congregation. Scarcely any of them have received the baptism of the Holy Spirit."

(When I went, they all received the baptism of the Holy Spirit that week. And though it was a small church which only took one offering a week for me, I received larger offerings than what I'd been averaging in churches much larger. God takes care of us when we obey Him.)

Jesus said to me, "In one case, every time you thought about it, that check in your spirit was the witness of the Spirit for you not to go there. On this other occasion, that green light in your spirit was the witness of the Spirit for you to go there."

The primary way the children of God are led is by the inward witness.

# Led by the Inward Witness

By Kenneth E. Hagin (SOME SAY HE'S THE "MODERN DAY MOSES")

*For as many as are led by the Spirit of God, they are the sons of God... The Spirit itself beareth witness with our spirit, that we are the children of God.*

— Romans 8:14,16

In 1959, the Lord Jesus appeared to me in a vision. At that time He talked to me quite awhile about the ministry of the prophet. In this vision He said, "I want you to teach My people how to be led by My Spirit." Then He quoted these two scriptures to me: "The Spirit itself [Himself] beareth witness with our spirit, that we are the children of God" (Rom. 8:16), and "For as many as are led by the Spirit of God, they are the sons of God" (Rom. 8:14).

Then Jesus said some things to me that are very important and that we need to know. If we aren't careful, we will want God to do things our way instead of letting Him do things His way.

He said, "I do not lead My people through the ministry of the prophet, and they are not to seek guidance through the ministry of the prophet, although I sometimes confirm some things through that ministry."

"Also, under the New Covenant, My people are not to seek guidance by 'fleeces.' The New Testament does not say, 'For as many as are led by fleeces, they are the children of God.'"

(If you want to know where I got this statement which I say so often, I got it from the Lord. I had never heard anyone say it until He did.)

## The Inward Witness Guides Us

Jesus went on, "The New Testament does say that as many as are led by the Spirit of God, they are the sons of God. I lead My children primarily by the inward witness. If you will learn to follow the inward witness, I'll guide you in all the affairs of life."

Then He said something that has proved to be a real blessing to me. It surely came at an opportune time. He said, "If you will learn to follow My Spirit, I will make you rich. I'm not opposed to my children being rich, I'm opposed to their being covetous."

I listened to what He said that day, and the greatest things that ever happened to me from a material or financial standpoint took place when I followed that inward witness. A certain opportunity came along and something like a buzzer went off on the inside of me to go ahead with it. I almost missed it, but I remembered what the Lord said, and went ahead with it. Following the inward witness certainly pays rich dividends.

What is meant by "the inward witness"? Most of us know in a sense, yet spiritual things are often indistinct to us because we're so occupied with the natural and the physical realm.

For instance, I was preaching in Texas at the time of this vision. A man from another part of the country had previously contacted me about preaching a revival meeting in his church — one of the largest Full Gospel churches in that state. He had talked to me personally, called me, and then written me. And I had tentatively agreed to come to his church for the simple reason I was going to be in his area and would have a little free time. At that time, I was traveling with a travel trailer, and I tried to stay in one area for longer periods of time instead of going "from here to there," so to speak.

I thought to myself, *I'll be in that area anyway and that would be the logical thing to do, so I'll accept his invitation.* (You can reason things out in your mind and miss it a lot of times.) I didn't particularly have any leading about it when I talked to him.

His letter to me requested confirmation of the date we had set up tentatively. I'd had his letter several days, and for three days I'd started to sit down and write him, but there was always "a check" in my spirit. So I thought, *Well, I'll just wait.* The very night the Lord appeared to me in this vision, it was my intention to write the next day and accept the man's invitation.

But the Lord said to me, "That check you sense in your spirit is the witness of the Spirit not to go, because it is not My plan."

(Paul mentions how he and his company were going into Asia Minor to minister and they "... were forbidden of the Holy Ghost to preach the word in Asia" [Acts 16:6]. I don't know how God dealt with them, but it is my opinion that the Spirit simply "checked" them. So they didn't go that direction, but went another direction.)

## The Prophet Gives Confirmation

The Lord said to me, "I'm not going to direct you about what churches to go to or what places to hold revivals through visions or the ministry of the prophet. Even though you see Me now [and I did see Him in this vision and I heard Him speaking, just as vividly as any man I ever saw or heard in my life] and I'm telling you not to go, I'm instructing you to learn to follow the witness of the Spirit from now on."

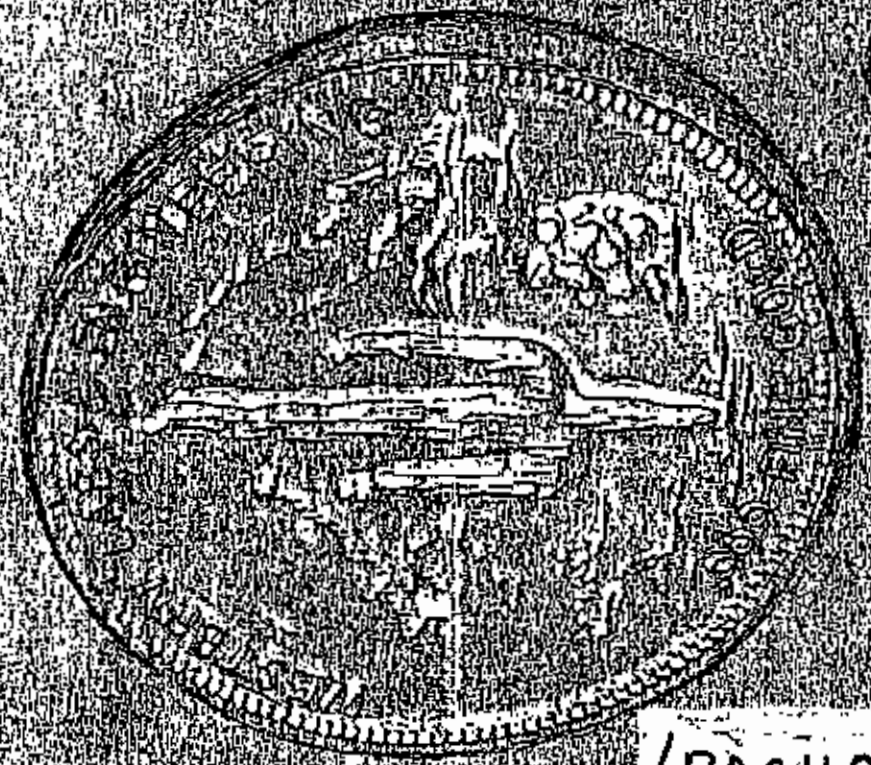
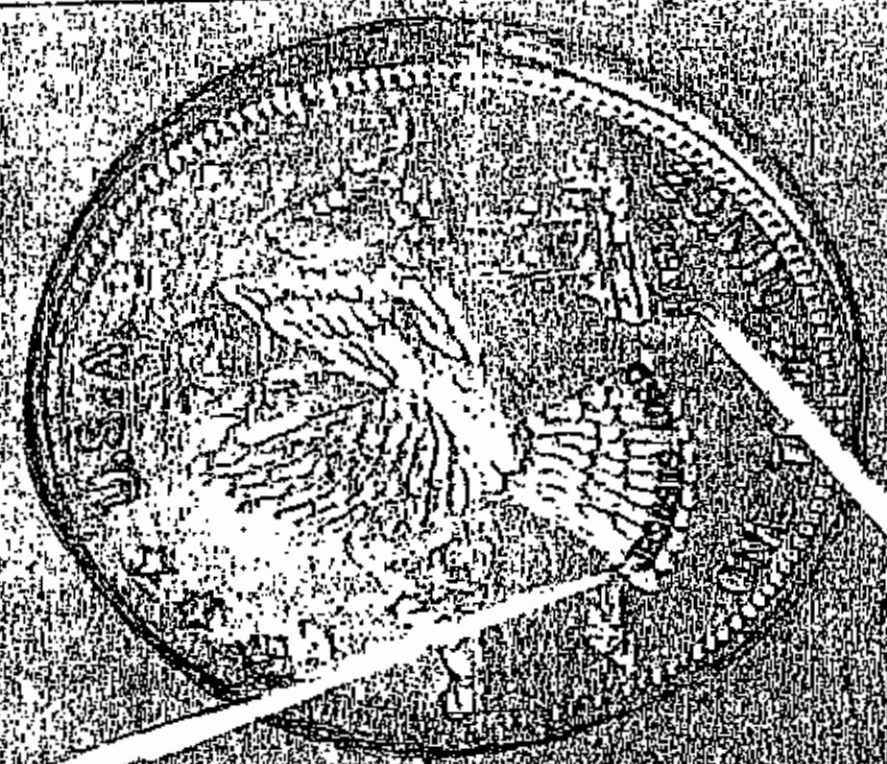
I never have had the Lord at any other time tell me to go or not to go somewhere for a meeting in a vision. And all He was doing then was simply confirming what I already had in my own spirit.

Jesus went on to say, "There is a point I want you to understand. The ministry of the prophet is not to direct people or guide people's lives; but it will do exactly what I just did for you. It will confirm what they already have. You already had the witness in your heart not to go to that meeting. All I did was simply to confirm it."

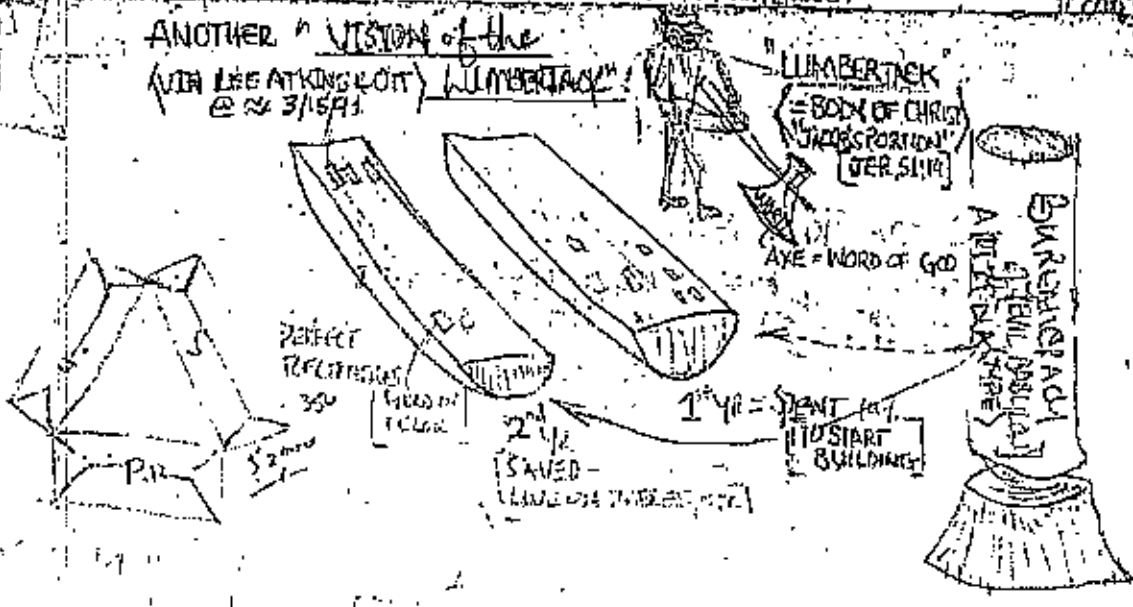

## (DAUGHTER OF DON BOWLES?) Christmas and life begins to make sense

Christmas is the day on which Christians celebrate the birth of Jesus Christ. For many believers, that holy day nearly 2,000 years ago is easily the most significant day in the history of the human race.

There is nothing complicated about the reason. They called Him Jesus, which in Hebrew means "Jehovah saves." His title was "Immanuel," which translates into "God with us."

Therein is the essence of Christianity. The Creator came to live among us, to gather our sins into Himself and to die in atonement for them. He who created us into this life promises to create us again, perfected into life eternal, making sense of it all.

That's what the celebration is all about. It's enough to make someone want to shout "Hallelujah!"

Christians are not popular in America these days. Jesus was not a very popular figure, either, in His last few years on Earth. His message threatened too many people, just as it does today.

He was the Truth they feared. His presence gave the lie to the self-serving illusions around which they had built their lives. He was the Light that illumined dark corners and recesses, exposing the sins they sought to hide.

He was the pure mirror that reflected back to them the image of the evil they had become. His very existence was a threat to their lifestyles and their rationalizations. They could not change or corrupt Him, so they killed Him.

It was all said in John 3:19-20: "And this is the condemnation, that light is come into the world, and men loved darkness rather than light because their deeds were evil. For every one that doeth evil hateth the light, neither cometh to the light, lest his deeds should be reproved."

Centuries have passed. Nothing has changed. They are still trying to kill Him. The fear, even the loathing, of His message is why the celebration of Christmas gets more pagan each succeeding year.

The United States is no longer a Christian nation -- or even a religious one. A massive assault on the religious community is rapidly taking on the ugly character of open persecution. Religious speech is routinely censored. The Creator of the universe has been excommunicated from the mainstream of American life. He is tolerated as long as He stays in His place. Those with the least understanding are always first in line to accuse Christians of being intolerant and judgmental. The fact is, no people in the world are more self-effacing than Christians. They are much more inclined to fault themselves rather than others.

Christians have accepted their own insufficiency. They know they are flawed and desperately in need of redemption. They are trying hard to do better. They are not trying to have their sins declared virtues. They seek to have their sins forgiven, not approved.

The sophisticate makes fun of religion and religious people, but if his car broke down at night on the other side of town, in a strange neighborhood, he would, given the alternatives, be thrilled if the first to come by were a born-again Christian.

Despite all the calumny and harassment, Christians are generally happy, well-adjusted and unimpaired by their faith.

Christians are not confounded by arrogant intellectual elitism which asserts that human existence is a meaningless event in an unending, mindless flow of meaningless events. They are unimpressed by the pompous, humanistic idea that we are born out of nothingness, to live and die only to disappear back into nothingness.

Christians know this kind of thinking makes absolutely no sense at all. They see this dark rhetoric for what it is: the verbal flailings of disoriented and frightened people who do not have philosophic handles on themselves or the universe in which they live.

Christians believe there are no throwaways in life. Everything matters. Nothing is insignificant, nothing is lost; the faded faces of the beloved dead, the sad memories of the happy days, the hurt that went unhealed, the unphotographed act of bravery, the fallen sparrow. None of these is forgotten; none is cast away as trivial or meaningless. All are forever important.

In the course of time, with the perspective of eternity, everything is reconciled, every detail attended, every wrong righted, every kindness thanked, every wound healed, every love requited, every sin atoned, every life vindicated, every loss recovered, every loved one found.

Life is not just some kind of glorious accident. The universe is rational.

It's enough to make someone want to shout "Hallelujah!"

I plead, on be-half of inmate Marshall Ott, ADC #94362 B26-206, for clemency. I do not pretend to judge his guilt or innocence. I was not there for his trial. I did not see the evidence or hear the witness.. I cannot know of his dept of involvement in the violation of law for which he is in prison. Therefore I base my plea upon the precepts of Christian love and compassion, and the fact that Marshall has already been more severely punished than many individuals who committed murder.

I can testify to Marshall's Christian inner-self. I have been involved with him in the Christian sphere since 1983 and have always found him to be honest and sincere.

I think of my-self as being a pretty good judge of character, since I was a policeman for over 26 years. I served with the New Orleans Police Department and the Louisiana State Police Department, and on detached service with the Baltimore, Maryland City Police Department. In the course of those 26 years, I worked in every position within the scope of Law-enforcement. Starting as a uniform officer on the beat and retired as a unit commander.

I would never, ever, lightly recommend clemency for anyone that I did not think would be worthy of it. Therefore I beg you to please consider this plea on behalf of my friend Marshall A.
